

FACT SHEET: MANAGING YOUR FUND

The Chester County Community Foundation provides Endowment, Quasi-Endowment, and Provisional Fund management services as follows:

1. Accounting: Contribution checks are posted to an Endowed, Quasi-Endowed or Provisional account designated specifically for your Fund. The Fund Advisor is sent quarterly reports which include deposits, disbursements, changes in the investments, and any fees charged. Upon request, reports can be e-mailed to a fund advisor anytime throughout the year.

2. Investments: The Community Foundation's Endowed Fund investments are currently invested with four firms: Hirtle Callaghan, First National Bank of Chester County, Weathervane Wealth Management, and Domini. The Endowed Funds are pooled assets and receive a monthly posting of the investment returns allocated on a pro rata basis based on an average daily balance. Please note that Provisional Funds under \$1 million do not accrue earnings, as they are meant to be short-term in nature.

Investment managers meet with the Investment Committee at least quarterly to review the investment portfolio and assess investment performance, and must adhere to the Community Foundation's formal Investment Policies.

3. Financial, Donor & Compliance Reporting: The Community Foundation provides:

- a) Contribution acknowledgement to donors;
- b) Contribution receipts for IRS tax compliance purposes (fund sponsored events, ticket sales, sponsors and corporate underwriters, and in-kind contributions);
- c) Accounting for pledges and pledge reminders;
- d) Annual audit and tax compliance.

The Community Foundation processes contribution acknowledgement letters and receipts for each donation. The Community Foundation uses a standard contribution receipt for all of our Funds. Arrangements can be made to allow for a special insert or letter from the Fund to its donors.

4. Fund Distribution: Upon receipt of written notification from the Fund Advisor/s, the Community Foundation processes grant checks. Grants can be made to IRS-qualified 501(c) (3) nonprofit organizations throughout the United States. By law, the Community Foundation must be sure that these funds will be used for a charitable intent, and not private inurement. The Community Foundation reserves the right to request evidence for any questionable requests, in order to assure that the funds are used for charitable purposes and as the donors intended. Endowment funds can make an annual distribution of 5% based on the fiscal year end (6/30) balance; Quasi-endowed funds can make an annual distribution of up to 20%; Provisional funds can distribute up to 100%.

FACT SHEET: INSPIRING PHILANTHROPY AND GROWING YOUR FUND

- The Chester County Community Foundation can help you grow your Fund by assisting with basic marketing initiatives.
- You can also help us inspire philanthropy in others by letting the Community Foundation highlight your Fund.

1. Publicity: CCCF highlights your Fund by listing it annually in the Community Foundation annual report. CCCF can work with you to draft and distribute press releases on your Fund initiatives. Selected Funds are also publicized on the CCCF website, highlighted during our annual meeting and in our annual report, and focused on at special events.

2. Flier/brochure development: CCCF can provide you with a basic flier or brochure template, developed in Microsoft Word or Publisher, and work with you to customize it to your liking. CCCF will provide you with 200 copies updated annually, if desired. Many people send their Fund flier to friends at holidays, birthdays and anniversaries as a way to encourage contributions to their fund.

3. Web page development and links: CCCF can provide you with a basic web page design to highlight your Fund, and limited programming customization. This page would be linked to your Fund's listing on the CCCF website. CCCF can also provide you with an individual web link-e-vite to enable your colleagues, friends and family to make secure on-line donations.

4. Planned giving administration: Because the Community Foundation holds your Fund in trust, we can administer a variety of planned giving services to benefit your Fund. We can help your donors and professional advisors by:

- a) Providing **bequest** language to benefit your Fund;
- b) Establishing and administering **Charitable Gift Annuities** to benefit your Fund; including providing tailored projections and calculations of income that beneficiaries can expect;
- c) Administering **Charitable Remainder Trusts** or **Charitable Lead Trusts** to benefit your Fund;
- d) Accepting gifts of **life insurance** to benefit your Fund; and
- e) Accepting certain gifts of **real estate** to benefit your Fund.

FACT SHEET: STRATEGIC, FOCUSED PHILANTHROPY
